Sport Fishing:

- ✓ Adventure tourism is gaining in popularity
- ✓ Growing interest for Sport Fishing
- ✓ Tourism demand for deep sea fishing trips is steadily rising



Sport Fishing with Passengers:

- ✓ Commercial Sport Fishing
- ✓ Fishing on vessels other than pleasure boats
- ✓ Commercial fishing license holders



Passenger:

CSA 2001

Person carried on a vessel by the owner or operator, other than

(i) the master, a member of the crew or a person employed or engaged in any capacity on board the vessel on the business of that vessel, or (ii) a guest on board the vessel, if the vessel is used exclusively for pleasure and the guest is carried on it without remuneration or any object of profit



Passenger:

Passenger – Anyone on a vessel except for the master, a member of the crew or a person employed or engaged in any capacity on board the vessel on the business of that vessel, or a guest on board a pleasure craft.

A fare does not have to be paid for a person to be considered a passenger.



Sport Fishing with Passengers:

- Commercial Sport Fishing Standards Project
- ✓ Limited NC2 HT III
- ✓ Only with lines
- ✓ Less than 6 persons
- ✓ Daily trips, without berth
- ✓ Inspected vessels
- ✓ SVCP-F



Commercial Sport Fishing:

The modification of a fishing vessel into a passenger vessel is complex

- ✓ Crew
- ✓ Construction requirements
- ✓ Intact and damaged stability
- ✓ Life saving equipment
- ✓ Structural fire protection
- ✓ Fire fighting equipment

Marine Personnel Regulations MASTER

Near Coastal Class 1 Voyages (more than 25 NM)

Master 150 GT

Near Coastal Class 2 Voyages (not more than 25 NM)

- ➤ Gross tonnage of more than 5: Master Limited
- ➤ Gross tonnage of not more than 5 and more than 8m: SVOP
- Of not more than 8m: SVOP

Sheltered Waters Voyages

➤ Maximum 6 passengers and at most 8m: PCOC



Marine Personnel Regulations Engineer

✓ Gross tonnage of less than 5, open boat, outboard engine propulsion = Engineer not required

- Near Coastal Class 2 limited voyages (not more than 25 NM)
- ✓ Small Vessel Machinery Operator (SVMO)



Marine Personnel Regulations MED

- Sheltered Waters Voyages
- ✓ MED with respect to Small Vessel Basic Safety (A3)

- ➤ Near Coastal class 2 voyages
- ✓ MED with respect to Small Passenger Vessel Safety (A2)

Hull Construction Regulations

(GT>15)

- Intact and Damaged Stability
- ✓ Passenger Vessels Operations and Damaged Stability Standards TP 10943, one compartment, three bulkheads.
- Bulwark, railings (height 1m)
- Collision bulkhead

LSER Class III

- ➤ Life rafts for 50% on each side (total 100%)
- Rescue boat under davit
- ➤ 2 Lifebuoys

Vessel Fire Safety Regulations (GT>15)

- Means of escape, stairways arrangement
- Structural fire protection
- > Fire detection
- > Fire pump
- > Fixed fire extinguishing system

- > Direct suction for bilge pumping in engine room.
